The Candidates applying for the post of LDA shall have to fulfill the following criteria:

1. Candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Age limit not below 18 (Eighteen) years and maximum 38 (Thirty Eight) years as on 01.08.2015.
3. Candidates must not have more than one spouse living in case of married candidate.
4. Age relaxation in case of SC/ST/OBC etc and reservation etc shall be as per existing Govt. rules/norms.
5. Candidates must have adequate knowledge in computer including Microsoft Office.
6. Candidates already in service should apply through proper channel.
7. Candidates will have to appear in a written test comprising General English and General Knowledge of 100 marks each. Qualifying candidates will have to appear in Oral Interview.
8. Application must be accompanied with the following:
 - a. **Self** Attested copies of certificate/diploma etc. in support of their Education Qualification.
 - b. **Self** attested 2 (two) copies of Passport size photograph must be enclosed with application.
 - c. 1 (One) self addressed envelop of 5 cm x 11 cm size affixing posted stamp of Rs.5/- only.
 - d. Incomplete application will be rejected and no application will be entertained after the scheduled date and time.


