1. The last date of receiving applications is 07.02.2022. Applications received beyond due date shall not be accepted and this office shall not be responsible for any postal delay.
2. Candidate must be an Indian citizen as defined in Article 5 to 8 of the Constitution of India.
3. The candidate must have minimum qualification of VIII standard passed and those who have passed HSSLC or above shall be ineligible to apply for the said post. Candidates possessing special skills may be given preference on need basis.
4. The candidate should not be less than 18 years and more than 40 years of age as on the date of publication of the advertisement. Age relaxation will be as per Govt. norms for reserved categories.
5. No T.A./D.A. will be admissible for appearing in written test/interview etc as the case may be.
6. Canvassing directly or indirectly will disqualify the candidature.
7. All information regarding date of interview will be intimated in the Official Website only.
8. The Final Selection will be made on the basis of the marks obtained by the candidate in written test/interview/viva-voce only.
9. The selected candidates will have to submit an undertaking to the authority that they will abide by the New Pension Rules of the Government.
