3. The candidate must have minimum qualification as stated above shall be eligible to apply for the said posts. Candidates possessing special skills may be given preference on need basis.
4. The candidate should not be less than 18 years and not more than 40 years of age as on the date of publication of the advertisement. Age relaxation will be as per Govt. norms for reserved categories.
